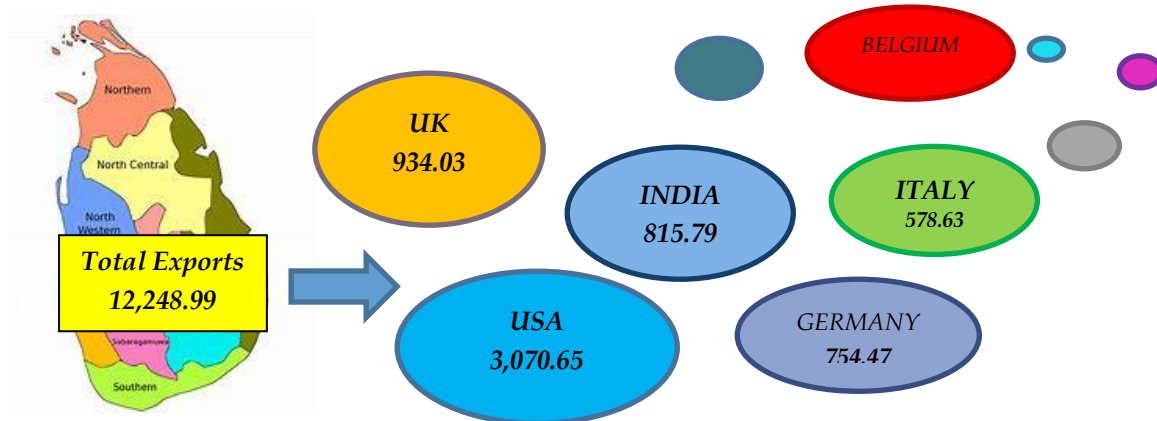

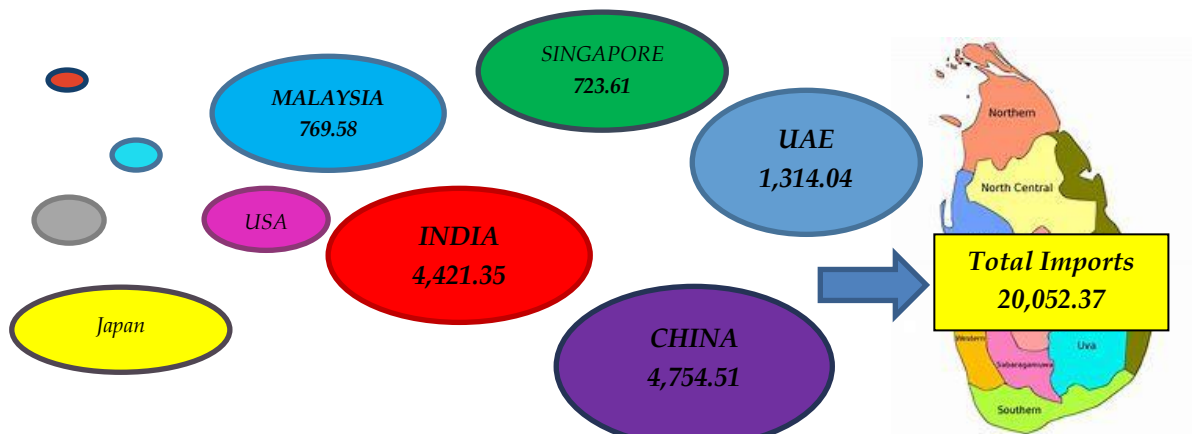

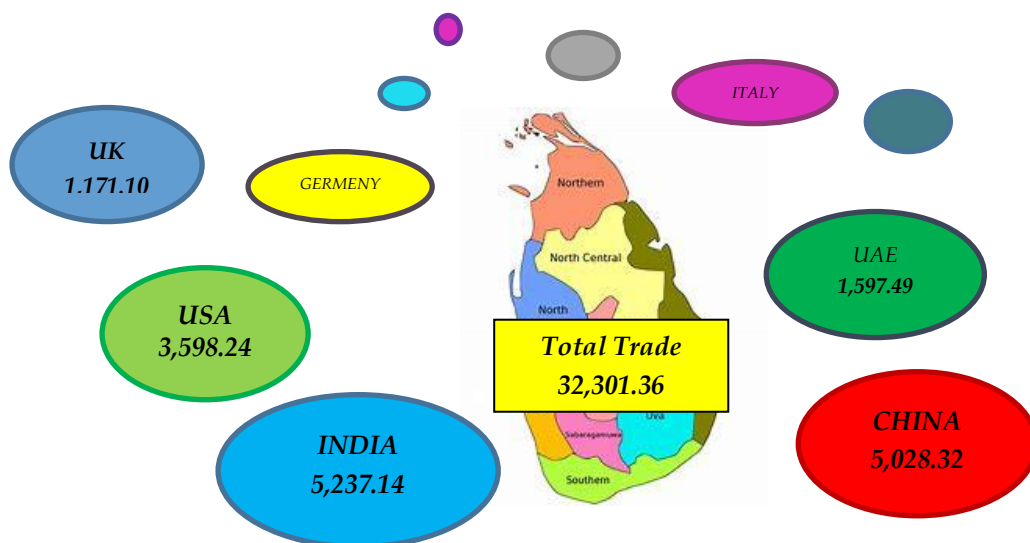
## Major Exports Values of Countries (US\$ Mn)

## Introduction

### The Origin of the Department of Commerce

*The Department of Commerce (which was formally known as 'Bureau of Commerce & Industry') has its origin which goes back to 1931. The Ceylon (State Council) Order in Council 1931 replaced the Ceylon (Legislative Council) Order in Council 1923 as the new Constitution of Ceylon in 1931, which was introduced under 'Donoughmore Commission'. This became one of prime instrument of constitutional reform in 'Ceylon'.*

*The Executive Committee on "Labour, Industry and Commerce" was one of the seven Executive Committees created under Section 32 of the new Constitution establishing the State Council. The State Council of Labour, Industry and Commerce was assigned the subjects of Commerce, the functions of the*

*Registrar General, Industrial welfare and Labour.*

*The 'Bureau of Commerce & Industry' under the Executive Committee of Labour, Industry and Commerce functioned as the key institution dealing with foreign trade policy formulation of 'Ceylon'. The Department of Commerce and Industry was created in 1938.*

*After independence, 'Department of Commerce & Industry' was converted into 'Department of Commerce' and assigned to the Ministry of Commerce and Industry on 29th September 1947, with the introduction of a Cabinet System of Government in 1947.*

### Functions of the Department of commerce

- 1. Safeguarding and promoting Sri Lanka's economic, trade & commercial interests at multilateral fora through effective representation and participation at discussions and negotiations at all levels (i.e. decision making and technical) at the World Trade Organization (WTO) and liaising & cooperating with likeminded WTO member countries to form common positions on issues of significant interest to Sri Lanka.*
- 2. Conducting negotiations to secure market access by gaining tariff concessions under non-reciprocal preferential trade agreements i.e. Generalized Systems of Preferences (GSPs) for Sri Lanka's exports.*
- 3. Conducting negotiations to secure preferential market access for Sri Lanka's exports under reciprocal trade agreements,*

*such as, Free Trade Agreements (FTAs) and Regional Trading Arrangements (RTAs).*

*Agreements under negotiation are as follows;*

- i. Bay of Bengal Initiative for Multi-Sectoral Technical and Economic Cooperation (BIMSTEC). Countries involved: Bangladesh, Bhutan, India, Myanmar, Nepal, Sri Lanka, Thailand*
- ii. China Sri Lanka Free Trade Agreement (CSFTA)*
- iii. Economic and Technology Cooperation Agreement with India (ETCA)*
- iv. Sri Lanka Thailand Free Trade Agreement (SLTFTA)*

4. Monitor market access related developments, both tariff and non-tariff measures in main foreign export markets and take coordinated actions by making effective & adequate representations at bilateral & multilateral levels for mitigating or eliminating the negative impact of such measures on Sri Lanka's exports.
5. Initiate coordinated actions to address specific market entry barriers in the import markets by formulating requisite standards/procedures at national level and obtaining approval/endorsement from the Regional /International Standard setting bodies.
6. Conducting awareness seminars/workshops on market access opportunities available under FTAs, RTAs and GSPs, in Colombo and regional cities.
7. Dissemination of information on market access related developments, both tariff and non-tariff measures in nature in the overseas markets and analyzing the impact of such measures on Sri Lanka's exports, including advocacy for addressing supply side constraints.
8. Advising and guiding exporters on becoming eligible for COOs under FTA, including consultations on rules of origin, production, procedural requirements, etc.
9. Expedient issuance of Certificates of Origin to facilitate exports under the following preferential schemes and
  - i. Generalized System of Preference (GSP)
  - ii. Global system of Trade Preference (GSTP)
  - iii. SAARC Preferential Trading Agreement (SAPTA)
  - iv. South-Asian Free Trade Area (SAFTA)
  - v. Indo-Sri Lanka Free Trade Agreement (ISFTA)
  - vi. Pakistan-Sri Lanka Free Trade Agreement (PSFTA)
  - vii. Asia-Pacific Trade Agreement (APTA)
  - viii. Singapore-Sri Lanka Free Trade Agreement(SSLFTA)
10. Organizing training programs/workshops with foreign resource personnel in Colombo and in regional cities on the topics related to new developments in international trade and WTO agreements.
11. Hosting of "Sri Lanka Trade Information Portal" with up to date information related to export and import procedures of 41 organizations, which disseminates all the requirements they need to comply with to import or export a specific good from and into Sri Lanka, in response to a single query.
12. Hosting of "Sri Lanka Trade Information Portal" with up to date information related to export and import procedures of 41 organizations, which disseminates all the requirements they need to comply with to import or export a specific good from and into Sri Lanka, in response to a single query.
13. Guiding and assisting the exporters to compile their responses of defense when their products are subject to anti-dumping investigations initiated by the importing countries.
14. Guiding and assisting the exporters to compile their responses of defense when their products are subject to anti-dumping investigations initiated by the importing countries.
15. Overseas Commercial Representation: The Commercial Representation comprises of 32 DoC officers serving in 30 Sri Lanka Missions abroad, who are engaged in promoting and safeguarding Sri Lanka's commercial and economic interests in the host countries.



16. *Conducting research on market access for existing and potential Sri Lankan products*

17. *Recommendation for Residence Visas:*

*Only for competent expatriates, consultants, specialists and their dependents employed at liaison offices, branch offices or foreign companies, other trade and commercial ventures, taking into account the direct benefits of such employments accrued for export trade, technology transfer and productivity improvement to the National Economy etc.*

18. *Approval of Credit Agencies:*

*Director General of Commerce is empowered to declare a company, firm, institution or individual as an approved credit agency Under the Mortgage Act No. 6 of 1949. Hence, the Director General will do so on the basis of a recommendation by a Board consisting of a Chairman and two other persons appointed by the Hon. Minister under Section 114 (1) of the Mortgage Act No. 6 of 1949.*

19. *Organizing/coordinating Joint Commissions/Committees (JCs) and Trade & Investment Framework Agreements (TIFAs). Currently, the DoC is responsible for 23 JCs and 02 TIFAs*

*\*Reasons for reduction of COOs issued under the EU GSP Scheme*

From 1 January 2017, the EU introduced a self-declaration system for companies exporting under the EU GSP Scheme. This Scheme, known as the EU REX system, allows exporters to submit their own "Statement on Origin" in place of the GSP Form A previously issued by the Department of Commerce (known as GSP Certificate of Origin). Companies registered on the system can submit their own declaration on the origin of their product, in the form of a statement to this effect on their commercial invoice.

Sri Lanka was granted a transition period till mid-2019 to fully implement the system which allowed companies to continue applying for COOs while undertaking the registration into REX. During this period, the Department of Commerce undertook measures to transition existing companies to the new system, while continuing to issue the GSP COO in parallel. Such measures included awareness-raising seminars and dissemination of information of the new system through other government agencies and through Chambers.

On the full implementation of the system from mid-2019, the EU no longer required or accepted the GSP Form A issued by the Department of Commerce. Instead, the DoC became the competent authority for processing and approving registration of companies on the system, as well as for monitoring companies' compliance of the rules of origin.

Because of the completion of the transition to the REX system by mid-2019, the number of EU GSP COOs issued by the Department of Commerce fell from 2018, as the "Statement on Origin" replaced the DoC-issued COO. Therefore, the reduced number of EU GSP COOs issued by the DoC in 2019 is reflective of this transition and full implementation, while zero numbers in 2020 reflects the full implementation of the system continuing into this year. No GSP COOs will hereby be issued by the DoC for EU exports.

## **Overview of the International Trade in Sri Lanka – 2021**

The total value of exports in 2021 was reported as US\$ million 12,248.99 which was a 23.9 percent increase compared to 2020 with US\$ million 9,886.31 export value. The USA was the largest buyer of Sri Lankan products in 2021, which had a share of 25.1 percent of total export value followed by UK, India, Germany and Italy. The above five export destinations covered 50.2 percent of total value of exports in 2021. Major export product to the world was Apparel (HS 61 and 62), which was the main foreign exchange earner covering 40.4 percent of total export value followed by Tea (0902), Retreaded or used pneumatic tyres of rubber (401290), Articles of apparel and clothing accessories (4015) and Cinnamon (0906) in 2021.

The total value of import was US\$ million 20,052.37 in 2021 which was a 28.7 percent increase compared to 2020 with US\$ Mn 15,586.14 import value. The major suppliers of Sri Lanka were China and India which covered 23.7 and 22.0 percent respectively of total import value in 2021 followed by U.A.E, Malaysia and Singapore. The above five suppliers covered 59.8 percent of total value of imports in 2021.

Petroleum oils and oils obtained from bituminous minerals other than crude (2710), Articles of iron and steel (7273), Knitted or crocheted fabrics (60), Plastics and articles thereof (39) and Pharmaceutical products (30) were the major five products imported to Sri Lanka in 2021.

## Balance of Trade

Balance of Trade <sup>(1)</sup> in Sri Lanka has recorded an average of US\$ Million -8,447.35 in the period from 2012 to 2021, which reached to a high value of US\$ Million -10,419.60 in 2018 and recorded a low value of US\$ Million - 5,699.83 in 2020.

It was reported as -7,803.38 in 2021. USA, UK, Germany, Netherlands and Italy were the first five countries which had positive balance of trade while China, India, UAE, Malaysia and Singapore indicated a negative balance of trade (major five countries) with Sri Lanka in 2021.

## Direction of International Trade of Sri Lanka

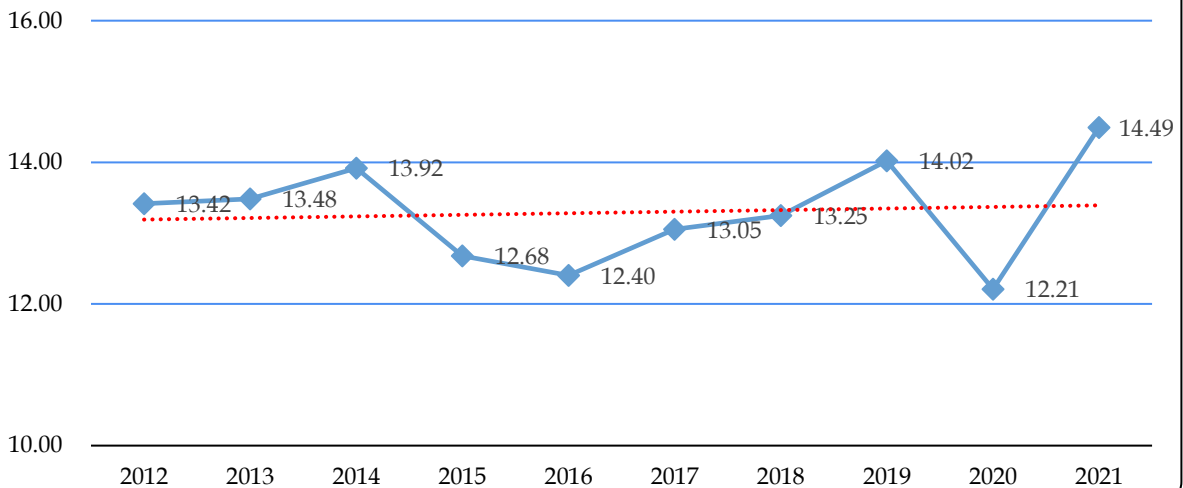
Figure 4: The percentage growth of Exports and Imports



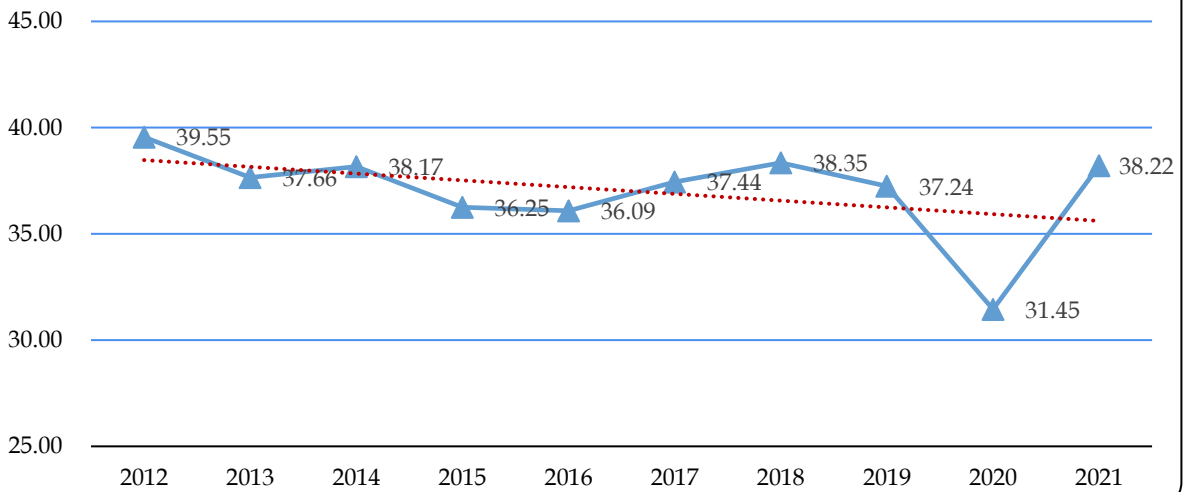
**Figure 5: Balance of Trade as a percentage of GDP**

USA and UK remained the largest export destinations for Sri Lanka while China and India were the foremost import originations of Sri Lanka during the last five years (see figure 4 and 5). While USA and UK covered 25.1 and 7.6 percent of total exports respectively in 2021, while China and India

Covered 23.7 and 22.0 percent of total imports of Sri Lanka respectively in 2021. India, Germany, Italy, Netherlands, Belgium, and Canada were the influential buyers of Sri Lanka while UAE, Malaysia, Singapore, USA and Indonesia were the dominant suppliers to Sri Lanka in 2021.

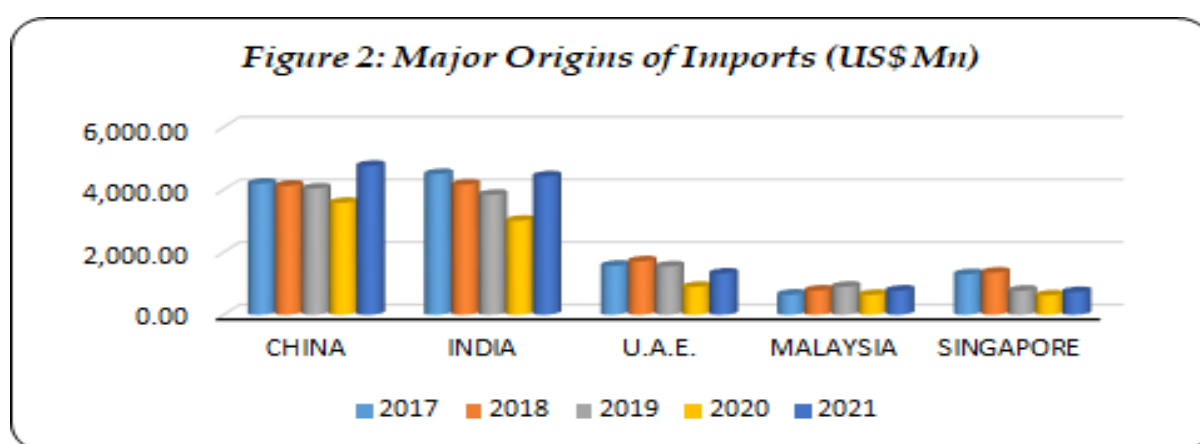

figure 3: Sri Lanka's export share in the world (%)

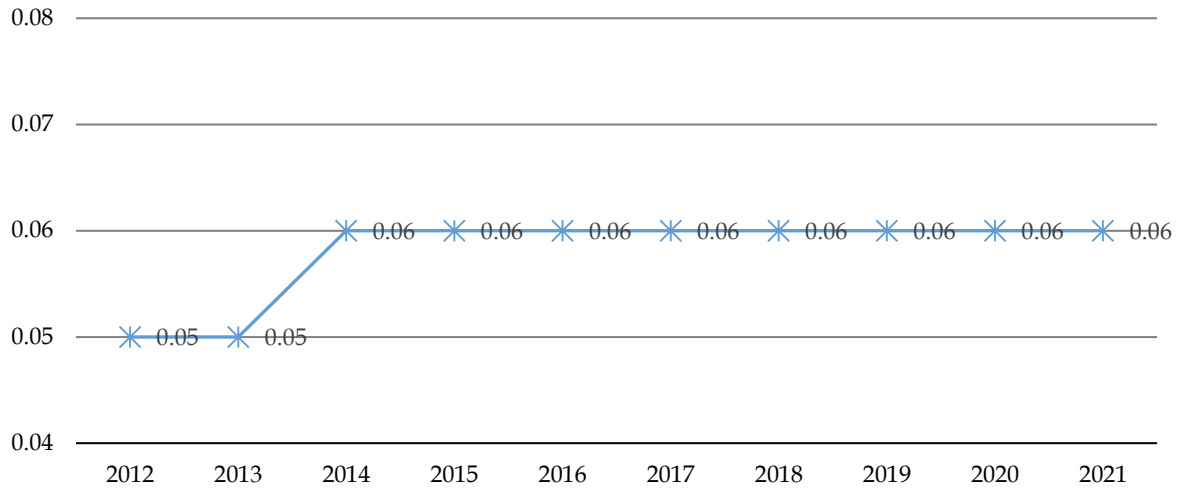
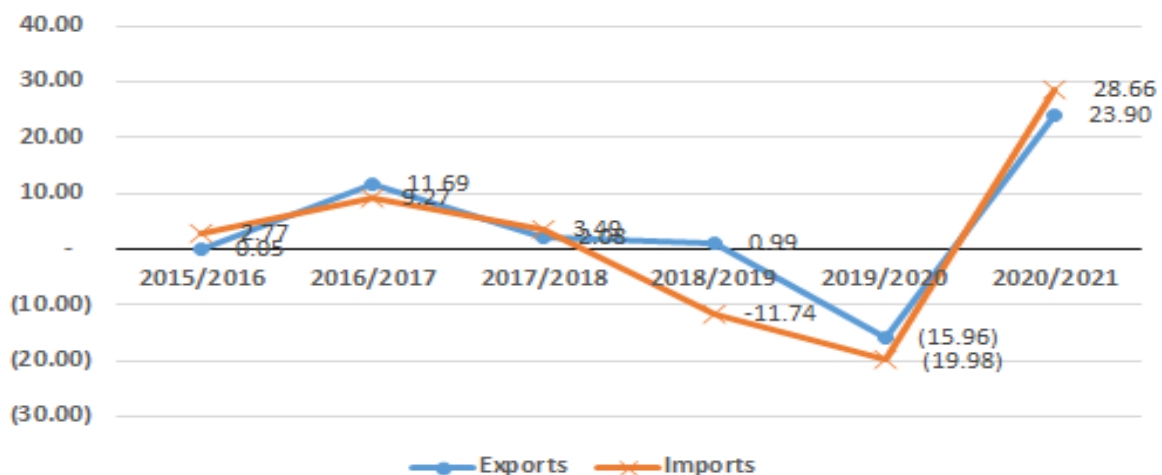


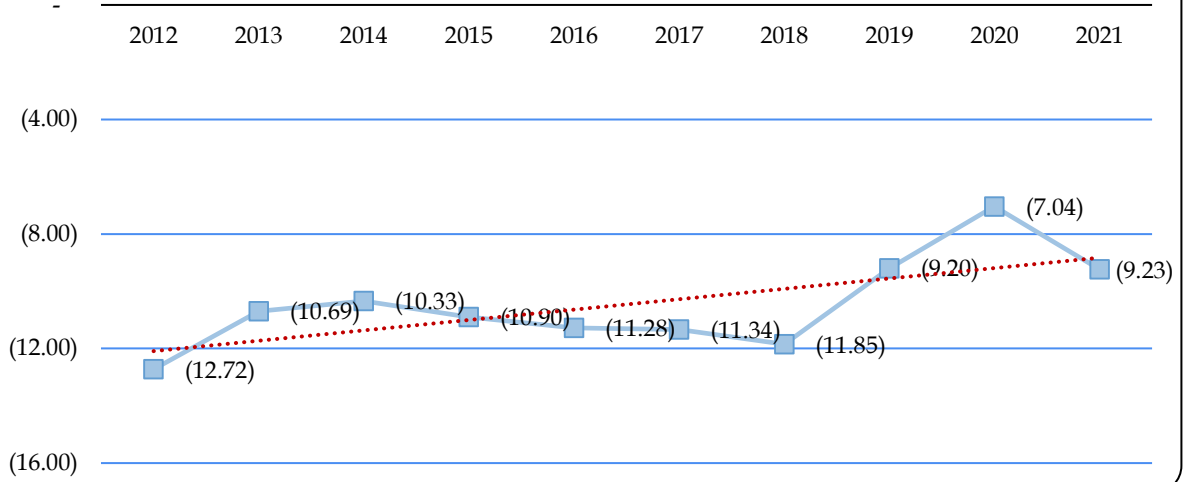

**Figure 6: Export as a percentage of GDP**



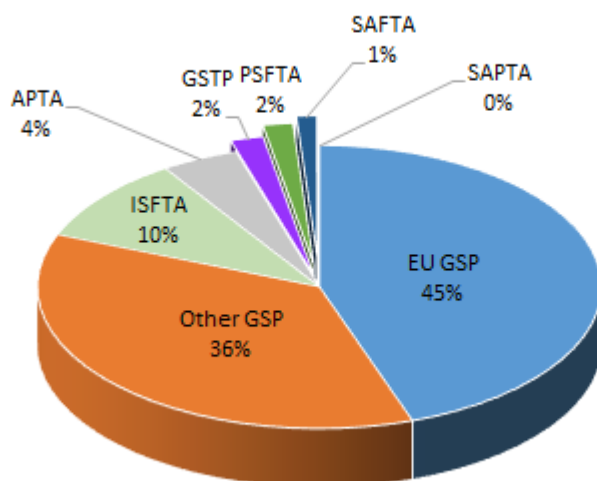
**Figure 7: Total Trade as a percentage of GDP**

**Figure 8: Share of Preferential Exports in 2021**

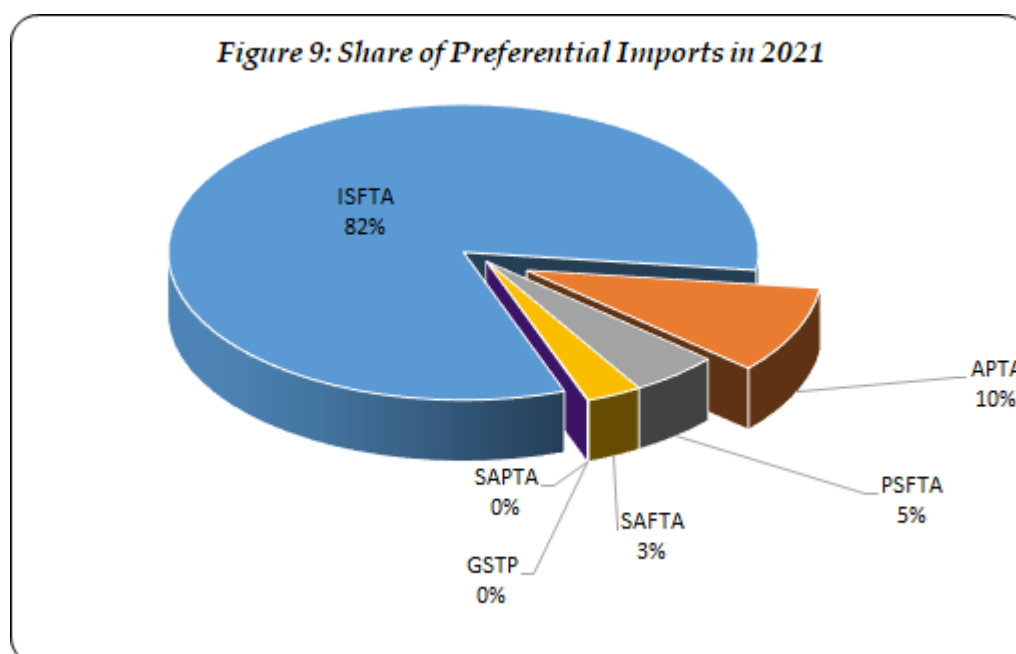

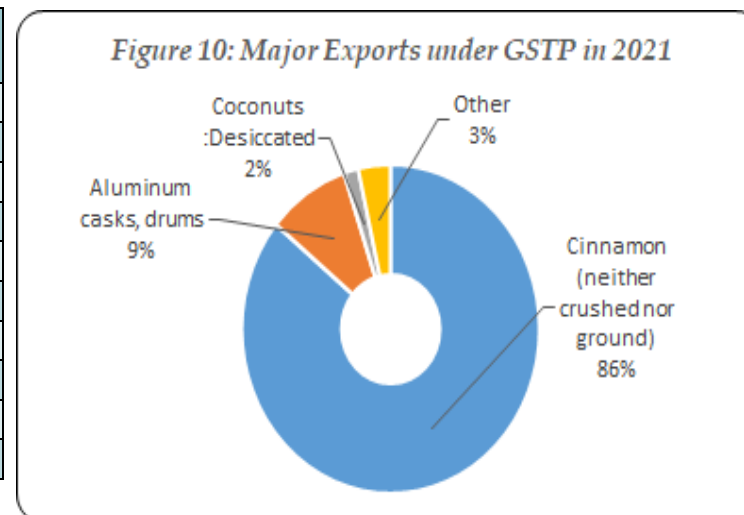

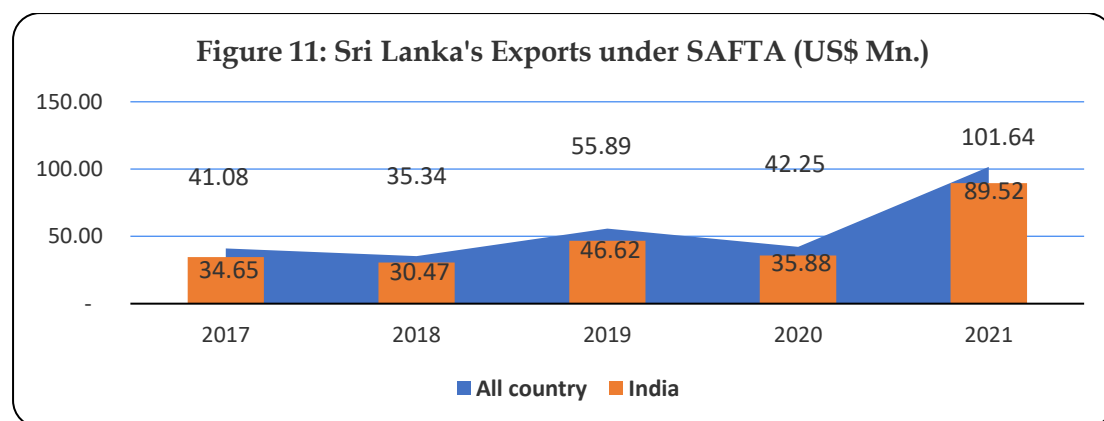

# Changes of Dollar Rate in Sri Lanka

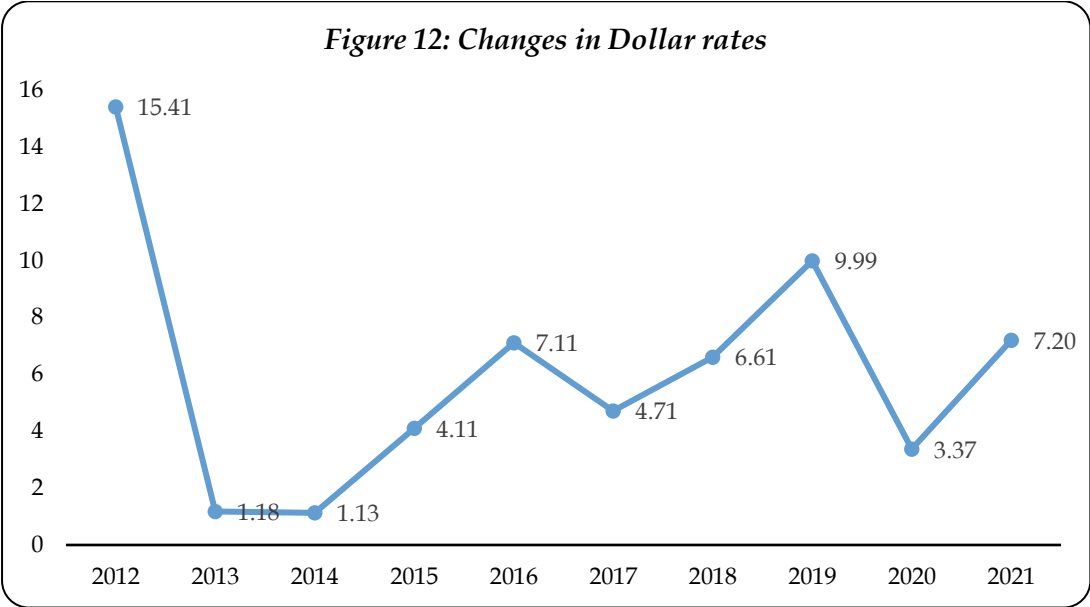
